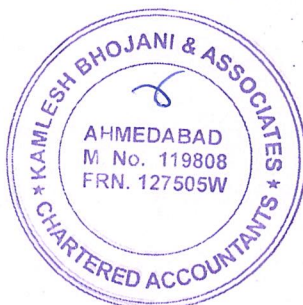

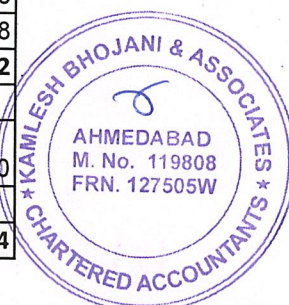

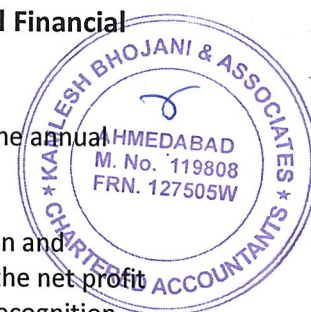
#### Basis for Opinion

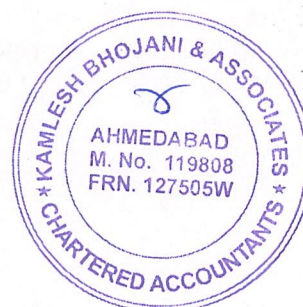
The Board of Directors is responsible for overseeing the Company's financial reporting process.
